TERMS & CONDITIONS

- Applicants must be attending or commencing a full-time 3rd level undergraduate level course. The course must be at least 2 years duration and approved by the Department of Education. Postgraduate students are not eligible to apply.
- Anyone in receipt of sponsorship of a course by an employer or earning an income connected to his/her course, from an employer, is not eligible to apply.
- Previous scholarship winners are not eligible to apply.
- Applicants must complete the application form.
- The winners of the scholarship will be required to verify their attendance at their relevant 3rd level college/university to receive their scholarship funds. Verification of attendance can be done by submitting proof of fee payment, letter of attendance or acceptance letter. Please note, if this is not received you will be deemed ineligible to receive the scholarship funds and a further draw will take place to pick another winner.
- All qualifying applications will be entered into a lottery draw.
- Winning members will be notified by letter and may be requested to take part in promotional activities associated with the draw.
- The Scholarship funds will be lodged into the winning student's Link Credit Union Limited account.
- The decision of the Board of Directors of Link Credit Union Limited will be final.
- Winning members must accept the publication of their names and the area they live in, as it is within Link Credit Union Limited and its members' legitimate interest to ensure that all matters pertaining to the operation of the scholarship are transparent.
